90 full time x 2,080 hours @ \$12.57 avg hourly wage	\$2,353,104.00
45 part time x 1,040 hours @ \$9.12 avg hourly wage	\$426,816.00
135 clients were hired for a total income estimate of	\$2,779,920.00
Average full time hourly annual earnings	\$26,145.60
Average part time hourly annual earnings	\$9,484.80

360 unduplicated clients were seen by Employment Services.

145 of those, or 38% of the total, found either full time or part time positions.

Once hired, **135** (93%) remained employed at least 90 days or longer.

 - transportation difficulties,
 - language barriers,
 - professional clothing,
 - childcare, and
 - educational shortfalls.

Rent or Mortgage Assistance **171** **95%** Irving families received assistance with payments were not evicted within 90 days of receiving assistance

Utility Assistance **195** **99%** Irving families received assistance with utility bills were not disconnected within 90 days of assistance

Money Management Clients receiving financial assistance attend a Money Management class online or in person. We provide classes in English and in Spanish. 340 clients took the class, and **97%** were able to identify three pieces of helpful budgeting information.

Food Pantry Staffed solely by volunteers 9 am to 3:30 pm Monday-Friday

727 Per month, an average of 727 Irving families received nutritious groceries

Q "In the past 12 months, were you ever hungry but didn't eat because there wasn't enough money for food?"

A 70% of the food pantry clients at Irving Cares answered "yes." **100%** said the food pantry helped prevent hunger in their household, and **98%** said the food pantry improved their ability to deal with a financial crisis.

Information & Referral

We gave **13,769** targeted referrals to other resources like Dallas County Health & Human Services, North Lake College, and Salvation Army in order to provide clients the best services.

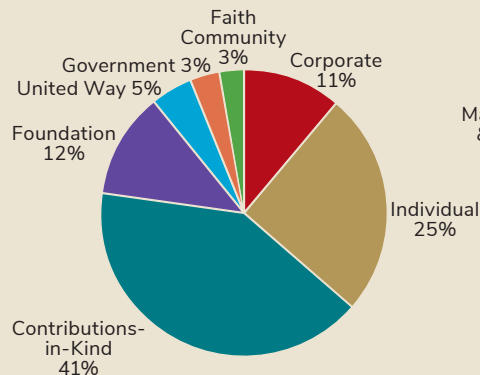

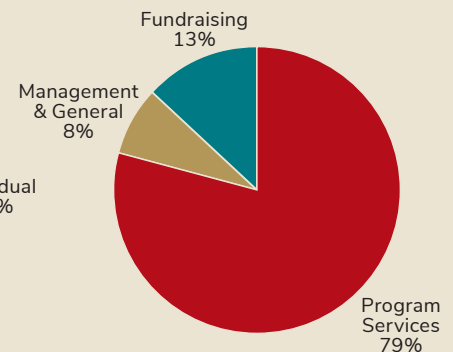
